5. POLL

If the election in respect any town/parish council is contested the poll will take place on **THURSDAY, 2nd MAY 2019**.

6. ABSENT VOTES

Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer, BROADLAND DISTRICT COUNCIL, THORPE LODGE, 1 YARMOUTH ROAD, THORPE ST ANDREW, NORWICH, NR7 0DU **by 5pm on Monday 15th April 2019** if they are to be effective for this election. Applications for a proxy vote must reach the Electoral Registration Officer by **5pm on Wednesday 24th April 2019**.

New applications to vote by emergency proxy on the grounds of physical incapacity or for work reasons must be received by not later than **5pm, Thursday, 2nd May 2019**. To be able to apply for an emergency proxy vote, the physical incapacity or work commitment must have occurred after **5 pm on 24 April 2019**.
